- 1. The candidates should apply without photocopies of documents on given format of application to the **Deputy Director Information & Selection Centre PAC Board Kamra, District Attock** within 15 days after publication of advertisement in
- The maximum age limit may be relaxed in the following cases:-
 - (a) 05 years age relaxation announced by the Government of Pakistan.
 - (b) 03 years in the case of candidates belonging to scheduled castes, Buddhist community, recognized tribes of the triba areas, Azad Kashmir and Northern Areas in accordance with the instructions issued by Establishment division Government of Pakistan.
 - (c) 03 years in the case of candidates belonging to Sindh (R) and Balochistan for the posts in the BPS-15 & below unde the federal Government rules.
 - (d) In case of Government servants of who have been in continues service at least 02 years or more on the closing date of receipt of applications, maximum age limit may be relaxed by 10 years.
 - In the case of released or retired officers/personnel of the Armed Forces of Pakistan, maximum age limit may be relaxed by 15 years.
 - (f) By 10 years in the case of disabled persons for appointment to posts in BPS-15 & below.
- (g) 05 years age relaxation in case of widows, son/daughter of deceased civil servant who died during service.
- 3. 10% quota for women, 2% for disable persons and 5% for minorities are reserved as per Government rules.
- 4. Those applicants who are already employed, must apply through proper channel after obtaining NOC from their departmen otherwise their applications will not be considered.
- 5. Incomplete applications or received after due date will not be entertained / considered.
- 6. Experience means post qualification experience gained in a regular full time paid job after attaining the prescribed qualification.
- 7. JCOs / Airmen who retired before completion of 25 years service after 01 January, 2007 will not be eligible for employment.
- 8. The name of the post should be clearly mentioned on the envelope.
- 9. Only short listed candidates will be call for test / interview.
- 10. Disable personnel are to submit disability certificate along with application duly verified by concerned District Social Welfare Officer.
